I (the above-named person) am above the age of 18 years or am the legal guardian of the above-named person who is under the age of 18 years. I am a guest of CAMP BLESSING TEXAS, INC. I may be participating in activities offered by CAMP BLESSING TEXAS, INC. on its premises, including kayaking, canoeing, swimming, fishing, hiking, ziplining, climbing, playing on fields, courts or open land, shooting, riding, and other activities (referred to singularly and collectively as "**Activities**").

In consideration of Camp Blessing Texas, Inc., and any of their agents, officers, managers, or employees (hereafter collectively referred to as simply "**Camp Blessing**") allowing me to use and stay on its premises and participate in the Activities, I hereby ACKNOWLEDGE THE RISKS AND RELEASE, DISCHARGE, AND INDEMNIFY Camp Blessing from any liability or harm related to the Activities, on behalf of myself and my heirs, personal representatives, and estate as follows:

- 1. Acceptance of Risks and Responsibilities.** I understand, acknowledge, and agree as follows: (a) I am voluntarily engaging and participating in the Activities, and it is my responsibility to restrict my participation in the Activities as appropriate; (b) the Activities bear certain risks which could result in injury, death, illness, or disease to me, spectators, or other third parties, as well as damage to my property or others' property; (c) some of the risks include: risks are inherent in the Activities; the acts, omissions, and negligence of me, Camp Blessing, and other participants, persons, or entities; defects in equipment used in the Activities; weather conditions; my physical, psychological, and emotional health, and that of other participants or persons; and other risks which may or may not be known at this time.

I assume all responsibility for and risk of injury, death, illness, and disease to me or to third parties, as well as for damage to my property and that of third parties, arising from my participation in the Activities.

2. ***Release.*** I hereby voluntarily **RELEASE AND FOREVER DISCHARGE Camp Blessing** from any and all liability, claims, demands, and losses which are related to, arise out of, or are in any way connected with my participation in the Activities, even if caused by the negligent acts or omissions of Camp Blessing.
3. ***Indemnification.*** I further agree, promise, and covenant to **INDEMNIFY AND HOLD HARMLESS Camp Blessing** from and against any and all claims and losses of any person arising out of or in any way connected with my participation in the Activities, even if caused by the negligent acts or omissions of Camp Blessing.
4. ***Covenant Not To Sue.*** I further agree, promise, and covenant **not to sue, assert, or otherwise maintain any claim against Camp Blessing** for any injury, death, illness, or disease, or damage to myself or to my property, arising out of or in any way connected with my participation in the Activities or from any claim asserted against me by third parties.
5. ***Acknowledgement of Effect of this Agreement.*** In signing this document, I fully recognize that if anyone is hurt or property is damaged while I am engaged in the Activities, I will have no right to make a claim or file a lawsuit against Camp Blessing, even if Camp Blessing negligently caused the bodily injury or property damage.
6. ***Agritourism Agreement and Warning.*** I understand and acknowledge that an **agritourism entity (such as Camp Blessing) is not liable for any injury to or death of an agritourism participant (such as me) resulting from agritourism activities (such as the “Activities”). I understand that I have accepted all risk of injury, death, property damage, and other loss that may result from agritourism activities, which include the “Activities”.**
